Please make sure you are current with respect to your medical certificate and flight review. We cannot allow you to participate in any tour if you are not current, nor if your certificate has been suspended or revoked.

Renting Pilots

We strongly suggest that you fly 5 hours in the make/model of the aircraft that you will be renting through us in the 90 days period preceding the tour. Our aircraft checkouts are meant to thoroughly prepare you for the tour, not polish your skills or familiarize you with a new make or model of aircraft. If you would like to come to Grand Junction a day or two in advance, we will gladly schedule additional time in your tour aircraft.
